

**REVIEW ACKNOWLEDGEMENT FORM OF AUB POLICIES AND PROCEDURES CONCERNING  
SEXUAL AND OTHER DISCRIMINATORY HARASSMENT**

The American University of Beirut has developed policies and procedures to address Sexual and Other Discriminatory Harassment in order to promote a safe and ethical work and academic environment in which members of the AUB community are free from discrimination and harassment of all kinds. For the purposes of this policy, the “AUB community” includes members of the Board of Trustees, officers, faculty, staff, academic appointees, students (including Medical Interns, Residents, and Fellows), visiting students, alumni, trainees, visitors, contractors, subcontractors, and suppliers, located on campus and at AUB Medical Center, Advancing Research Enabling Communities Center (AREC), as well as all affiliated programs or facilities associated with AUB. The “AUB community” also includes the dependents and domestic employees of faculty and staff dwelling on campus and at AREC.

AUB’s Title IX Coordinator, based in the Office of the President, is responsible for the overall administration of the university’s Equal Opportunity and Title IX program and compliance efforts. The Title IX Coordinator is a resource for all members of the AUB community.

Academic and non-academic department/unit heads, managerial level staff, academic advisors, protection officers, and residence hall staff/monitors are obligated to report actual discriminatory harassment including sexual harassment or sexual violence to the Title IX Coordinator or to a Title IX deputy.
